ROWING RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY
AND PARENTAL CONSENT AGREEMENT ("AGREEMENT")

IN CONSIDERATION of (name of participant) _____ being given the opportunity to participate in any (Event/Rowing Club) HHI Crew (including but not limited to the HHI Crew Club & Palmetto Rowing Club) all regattas we row and participate in ("Club") United States Rowing Association sponsored activities ("Activity") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature of Rowing Activities, both on water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe condition to be unsafe, I will immediately discontinue further participation in the Activity.
2. FULLY UNDERSTAND that: (a) ROWING ACTIVITIES INVOLVE RISK AND DANGERS of serious bodily injury, including permanent disability, paralysis and death ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity, the condition in which the Activity takes place, or the negligence of the Releases name below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.
3. HEREBY RELEASE, discharge, and covenant not to sue U. S. Rowing, Hilton Head Island Crew, Town of Hilton Head Island, and the Island Recreation Center, their administrators, directors, agents, officers, volunteers, and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the Releases herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releasees, from any litigation's expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim.
4. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such to the attention of the nearest official immediately.
5. I also willingly agree that if I cannot transport my child personally to a club sponsored event and that another parent or club representative transports my child that I release, discharge, and covenant not to sue said parent or club representative from all liability, claims, demands, losses or damages caused by any situation that does not prove said parent or club representative negligent.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

PARENTAL CONSENT
